## 4. Annual Board of Directors Meeting in South Lake Tahoe

The Board of Directors typically conducts one Water Agency meeting in the Lake Tahoe Basin each calendar year to accommodate the east slope purveyors and the constituents they serve. This meeting was scheduled for August 9, 2023; however, an administrative conflict arose. Staff is recommending to conduct the Water Agency's regularly scheduled meeting on October 11, 2023 in South Lake Tahoe. Staff at South Tahoe Public Utility District confirmed the availability to use their Board Meeting room on this date.

RECOMMENDED ACTION: Staff recommends the Board of Directors agree to conduct the October 11, 2023 regularly scheduled Board meeting in South Lake Tahoe at the South Tahoe Public Utility District offices.

## 5. Consideration of Vendor Pool Request for Qualifications

The EI Dorado Water Agency (Agency) uses engineering and environmental professional services in carrying out its work plan each year. Access to a pool of prequalified service providers allows staff to efficiently contract for services while still maintaining a competitive process. On June 29, 2016 the Board authorized execution of 3-year master vendor pool agreements with consultants for engineering, environmental and other services to meet the needs of the Agency. The previous vendor pool has expired. In order to prepare a new vendor pool list of prequalified firms to assist the Agency a new Request for Qualifications (RFQ) solicitation is needed.

**RECOMMENDED ACTION:** Staff recommends the Board: 1) approve the solicitation of requests for qualifications for the vendor pool; 2) approve increasing the duration of the master vendor pool agreements to 5 years; and 3) approve publishing requests for qualifications online only.

#### 6. Outdoor Water Conservation Projects

In October 2020, the County of El Dorado and the Agency entered into a funding agreement for the Agency to implement water saving projects on non-County owned facilities/lands to prevent the waste of water and to achieve a water savings of at least 9 acre-feet per year. Staff will provide an update on the associated water saving projects and is seeking authorization for the Interim General Manager to enter into an agreement with Georgetown Divide Public Utility District to support a water savings project that would line a portion of the Georgetown Canal.

**RECOMMENDED ACTION:** Staff recommends the Board authorize the Interim General Manager to enter into an Agreement with Georgetown Divide Public Utility District in a form acceptable to legal counsel for a not-to-exceed amount of \$34,280 for the Canal Lining Project.
