DISCUSSION CALENDAR:

4. Upper American River Watershed Group Update

Staff will present on the Water Agency's Watershed Program, which recognizes that long-term water resources resiliency and reliability across the county depend on the health of the watershed. As the convenor of the Upper American River Watershed Group (UARWG), made up of local, state, and federal agencies, Tribes, utilities, environmental groups, and other partners, the Water Agency supports a collaborative approach outlined in the 2023 Programmatic Watershed Plan. This plan focuses on promoting watershed health and community resilience by improving natural, built, and social infrastructure. Staff will also share outcomes from the September 16, 2025 UARWG workshop, where members identified three priorities for the year ahead: 1) developing a collective identity, 2) building a data management framework, and 3) including co-benefits in projects.

RECOMMENDED ACTION: Staff recommends the Board receive and file the presentation.

5. GIS Portal Update and Approve Agreement with County

The El Dorado Water Agency (Agency) hosts a GIS Portal on its website. Currently, the GIS Portal uses the County of El Dorado's (County) Esri's ArcGIS Online account and only County staff have access to make changes to the GIS Portal on behalf of the Agency. To improve efficiency and provide the Agency with ready access to its GIS Portal, the Agency is requesting Board approval for an agreement with the County to have an Agency specific ArcGIS Online account within the County's ecosystem, allowing the Agency to manage and update its GIS Portal directly.

RECOMMENDED ACTION: Staff recommends the Board authorize the General Manager to enter into an agreement, in a form acceptable to legal counsel, with the County of El Dorado to have an ArcGIS Online Creator account within the County's ArcGIS Online environment, allowing the Water Agency to directly manage and update its GIS Portal. The Fiscal Year 2025-26 cost is \$550 for a Creator account. Subsequent fiscal year costs are subject to budget availability.

6. 2025 Agricultural Applied Water Validation Study

Staff will present on the Applied Water Validation Study finalized in September 2025. The Study updated irrigation water estimates from the 2020 El Dorado County Agricultural Development Feasibility Assessment and provides a clearer understanding of on-farm water use in the West Slope of El Dorado County. Having a refined understanding of applied water demands will inform planning efforts for long-term water supply needs to support the planned growth of irrigated agriculture in accordance with the adopted County of El Dorado General Plan.

RECOMMENDED ACTION: Staff recommends the Board receive and file the presentation.

7. Board Meeting Location

The Water Agency currently holds its regular Board meetings at the Agency office. At recent meetings, it was suggested that Board meetings should consider being held at the County Government Center to improve access and encourage involvement by other agencies in the county. This item provides an overview of the considerations of each potential meeting location. The purpose of this report is to allow the Board with sufficient information to discuss and provide direction to staff on the preferred location for future meetings and the process for securing the room.

RECOMMENDED ACTION: Staff recommends the Board of Directors: 1) discuss the considerations associated with each potential meeting location; 2) provide direction to staff regarding the location of future Agency Board meetings through the end of the adopted 2025/26 Board calendar (through February 2026); and 3) provide direction to staff on process for securing the room.

8. Change to November and December 2025 Board Meeting Dates

The last two regular Board of Directors meetings for the calendar year are currently scheduled for November 12, 2025 and December 10, 2025. However, scheduling conflicts since the adoption of the calendar have arisen. Therefore, considering these conflicts, staff is recommending replacing the two meetings with one Board of Directors meeting on Thursday December 4, 2025 at 10am.

RECOMMENDED ACTION: Staff recommends the Board (1) approve the cancellation of the November 12, 2025 meeting and the rescheduling of the December 10, 2025 meeting to December 4, 2025; and (2) provide direction to staff regarding location of meeting.
